

NOTICE OF MEETING OF THE CITY COUNCIL
CITY OF ODEM, TEXAS
SEPTEMBER 23, 2025

Notice is hereby given that the City Council of the City of Odem will meet at the Odem Public Library, 516 Voss Avenue, Odem, Texas at 7:00 p.m. in a **SPECIAL CALL MEETING** on September 23, 2025, and the following matter will be the subject of the **SPECIAL CALL MEETING**:

I. CALL MEETING TO ORDER:

- A. Declare a quorum
- B. Pledge the Allegiance to the Flag of the United States and the Texas Flag
- C. Public Comments - Citizens to be heard - **PLEASE LIMIT COMMENTS TO THREE {3} MINUTES.**
A PERSON SHALL NOT BE ALLOWED TO ASSIGN THE THREE {3} MINUTES TO ANYONE ELSE.

II. DISCUSSION AND ACTION ITEMS TO BE CONSIDERED:

- A. Discuss, consider and take action to adopt the proposed 2025-2026 Annual City Budget with a record vote being required.

This budget will raise more revenue from property taxes than last year's budget by an amount of \$11,922, which is a 1.38 percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$15,749.

- B. Discuss, consider and take action to adopt a tax rate with the following language included in the ordinance.

This year's proposed tax rate exceeds the no-new-revenue tax rate. The vote on the ordinance, resolution, or order setting the tax rate must be a record vote and 60% of the governing body must vote in favor of the adoption of the tax rate. A motion to adopt the ordinance, resolution, or order must be made in the following form:

I move that the property tax rate be increased by the adoption of a tax rate of 0.603323, which is effectively a 14.66 percent increase in the tax rate.


If this year's proposed tax rate does not exceed the no-new-revenue tax rate. A motion to adopt an ordinance, resolution, or order setting the tax rate does not require the language about "tax increase" as stated in §26.05(b) of Property Tax Code.

- C. Discuss, consider and take action to approve the setback variances requested by Jesse Falcon for the property located between 502 and 507 W. Sellers Street, Property ID: 46764, Acreage: 0.08.
